(I) That in the event of my / our application being approved I/we shall be bound to use Zellco Cellular Service ( herein after referred to as "the Company") for a minimum period of 24 (twenty four months. Terminations prior to this period results in breach of contract .

(ii) That payment for all balances will be made within 15 (fifteen) days of the date of the Company bills .

(iii) That non-payment will immediately render the total outstanding balances due and payable .

(iv) That should I / We default on monthly payment, interest charges will be raised and become payable at 2 ½%above the overdraft lending rate charged by commercial banks to Zellco Cellular from time to time. Any charge in the interest rate charged to me/us shall be advised on my/ our account and shall be effective from the first day of the month following that account.

(v) That whenever the outstanding balances exceed the credit limit advised by the company in acceptance of this application, payment of any such access will be made immediately on demand .

(vi) That I / We will be liable for any calls made on my/our line(s) on the same basis as if I / We made the call(s) myself/ourselves
